▶ Senior citizens age 65 and above can check whether they satisfy the eligibility requirements for automatic payment for this year via the Macao One Account/Social Security Fund's website

▶ Those who satisfy the eligibility requirements for automatic payment will receive a text message reminder. They need not go through any

formalities, and the funds will be automatically deposited on

25 September

in the bank account that is currently receiving old-age or disability pension

Starting
1 August

Apply for fund withdrawal



▶ Persons who are not eligible for automatic payment and belong to the three categories below need to apply for fund withdrawal themselves

- Age 65 and above
- Under age 65 and currently receiving disability pension from the Social Security Fund for more than 1 year
- Currently receiving Special Disability Subsidy from the Social Welfare Bureau

25 September
Payment of funds

▶ Those who applied via the Macao One Account / self-service machine in August

23 October
Payment of funds

▶ Those who submit paper applications in August and those who apply in September

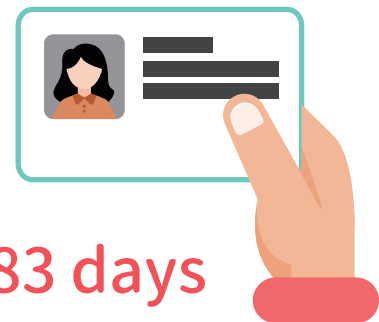

2 Eligibility requirements for allocation of funds

- The person was a permanent Macao SAR resident who attained **age 22** in **2023**;
- He or she was still alive on **1 January 2024**;
- He or she was in the Macao SAR for at least **183 days** in **2023**.



★ Residents who are eligible for allocation of funds for the first time are entitled to a one-time incentive basic fund of 10,000 patacas at the same time.
