Documents Required according to Category of Application

Category of Application	Required Documents
A. Reunion of husband and wife	Certificate of marital relation (<i>Please see Acceptance Standard for Documents of Residence Authorization for details</i>)
B. Reunion with de facto marital partner	Certificate of no marriage, divorce or de facto marital relation (<i>Please see Acceptance Standard for Documents of Residence Authorization for details</i>)
C. Reunion of minor and parent(s) residing in Macao	<p>1. When either parent is not a Macao resident, a written declaration of that parent's consent to let the minor reside in Macao with the other parent and the reasons for it should be submitted; <i>[Note: The signature of the declarant on the above declaration should be authenticated by the competent authorities. Otherwise, the declarant is required to sign the declaration in front of the staff receiving the application for residence and present the original of his/her identification document for authentication.]</i></p> <p>2. Document of habitual residence in Macao of the interested person and the reuniting parent(s) (e.g. proof of interested person studying in Macao, proof of parents' employment in Macao). <i>[Note: Application should be made by interested person's parents or guardian (or their legal representative).]</i></p>

D. Reunion of adult child with parent(s) residing in Macao	<p>1. Document of marital status of the adult child; <i>[Note: Please see Acceptance Standard for Documents of Residence Authorization for details, but the joint declaration of maintaining marital relation is not required if married.]</i></p> <p>2. If married, a copy of the identification document of the spouse and children (if any) should also be submitted;</p> <p>3. Written declaration of family member status made by the parents (e.g. number of children, their ages, the type of documents they have, their place of residence, their marital status, whether they are Macao residents, etc.). <i>[Note: According to Item 5, Article 2 of Law No. 16/2021, adult children are not included in a family household. Therefore, the security authorities generally do not approve applications for family reunion of adults and their family members who are Macao residents. Unless under very special circumstances with sufficient proof and for public interests and humanitarian reasons, exceptional approval will be given.]</i></p>

Certificate of birth of child residing in Macao <i>(Please see Acceptance Standard for Documents of Residence Authorization for details)</i>; 2. Certificate of marital relation of parents <i>(Please see Acceptance Standard for Documents of Residence Authorization for details)</i>; 3. If the parent is divorced or is a widow/widower, a certificate of his/her marital relation or a death certificate of his/her spouse should also be submitted <i>(Please see Acceptance Standard for Documents of Residence Authorization for details)</i>; 4. Same as D3 of this table.
